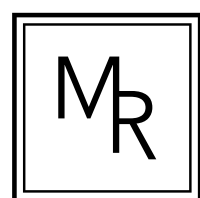

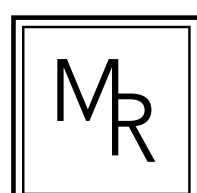
FLOOR 16 (3D)
